Need to Train the Library Professionals in Technology Era for Professional Development

Abstract

Professional library staff are experiencing new issues and challenges due to use of ICT and emerging technologies in libraries. It is vital to train library staff and also participate in training programmes for enhancing the skills in use of technologies and provide better facilities to users from the libraries and services. Professional growth can take place within or outside the organization with the help of training. A trainer's job is to help people and build the competencies and skill sets among them which they need to perform in their jobs effectively and efficiently. The trainer should communicate to the trainees what is expected from them as a result of giving the training.

Key Words: Professional Library Training, Train the Trainers, Professional Skills Development, Building Competencies, Capacity Building

1. Introduction:

Academic libraries are transforming continuously since past few years. The causes are advancements and trends in the library profession, applications of ICT, use of internet, web technology, social media applications, open source resources, changing practices in education system and emerging technologies and software which can be useful to libraries. All these developments have made its impact on the library activities, functions, services and library profession and professional staff. Library professionals are facing new challenges in managing the changes and sustainable future. No doubt library professionals are adopting to the emerging technologies for the better development of academic libraries. But it is also necessary to train the existing library staff to adjust with the emerging developments easily and apply in the profession efficiently. Training makes it possible for the professionals to manage the change and bring organization's continuous professional development. Train-the-Trainer is a term for training given to subject experts which later train to other people. The result of such training to experts helps in learning new knowledge or skills in profession, and they will train others later. The employees / trainers receive a compact training which mainly focuses on specific area of training and then conduct training for others.

2. Why Training is essential to Professionals?

The term "training" refers to the process of transmitting knowledge to gain specialized abilities for performing

specific goals in the profession. Training is a continuous activity which keep employees or professionals informed about new developments and changes in the profession and to adopt it suitably. The benefits of the professional training are: eliminating weakness and gaps in the skills and develop capacity to manage the change, improve professional performance due to attaining confidence of performing the function, better the trading better the performance which leads to attaining satisfaction in the profession. Training permits the professionals to enhance their consistency in performing the functions. Professionals gain rewards and reputation in the profession by attaining the task sincerely. Trained professionals help in increasing the productivity in work culture.

3. Purpose of Training to Library Professional:

The library professionals are trained in theoretical concepts and also practical concepts during completing the education process of UG, PG and research. However, there is a need to train the professionals during performing the actual role in the profession to update themselves with new techniques and technologies, and enhance their skills. They use skill sets to manage the goals and objectives of the profession. Due to professional training in the library sector, professionals receive motivation, job satisfaction, and their morale are improved. Training supports library professionals to enhance their capabilities in performing different tasks in the libraries, manage the change successfully, increase productivity in services. The main purpose of the training is to develop job related expertise among staff, attain skill sets to manage the tasks and achieve standardization in the process. Specific training to staff helps in handling ICT tools, equipment's efficiently in libraries.

4. Nature of Training Programs in LIS:

The different types of training courses, programs, workshops etc. can be made available are: training for skills development (Literacy training skills, Information product generation skills, marketing and revenue generation skills, negotiation skills, communication skills, evaluation skills etc.) creativity and advance tools management training (to develop innovative concepts among professionals), security and safety training, disaster management training, training on IPR and standards, information or literature search training, online search training, training in management techniques and tools applications (role playing, cost benefit analysis, PERT/ CPM, SWOT etc.) etc. Training is thus crucial for professional development and success.

In a library and information setting, "Continuing Professional Development" (CPD), sometimes known as "Continuing Professional Education" (CPE), is the process through which library and information specialists

maintain their professional competence throughout their careers. Through frequent in-service training and education, as well as external courses in the LIS field, the 'Career Development Process' enhances and updates the skills, talents, and competencies of employees 2016 (Duarah). LIS professionals must be effectively trained in the use of technologically oriented methodologies, which is a requirement of the current information and ICT era. In the LIC and libraries, "on-the-job training" (training in a real-world setting, learning by doing; job rotation, etc. are involved.) and "off-the-job training" (methods include workshops, seminars, conferences, online training etc.) both are possible. There are three techniques or approaches applied to increase library staff competency levels: a) "pre-service training" (which prepares individuals to enter the profession), b) "in-service training" or "staff development training" (which provides learning opportunities in the workplace), and c) continuing education (includes supplementary learning activities related to profession).

5. Areas in which library staff need training:

The new entrants as well as junior professionals in the field need the training from the senior professionals in the LIS field or technology field. The possible areas are:

- New, upcoming or emerging technologies can be used in the library profession.
- Data, mining, data management and data analytics
- Thorough training in use of various databases like science direct, springer link,
- New open source softwares for content management, building webpages, information gateways, Knowledge of Web-related languages and technologies, Web design, etc.
- Use of social media in libraries effectively (YouTube, Facebook, Blogger, Flickr, Twitter, RSS etc.)
- IoT (Internet of Things), search engines, sharing information on net, etc.
- Developing digital libraries, Digital technology, Digital imaging and formatting and virtual libraries, e-content development, OER creations to support e-learning
- Applications of Management tools and techniques in the profession to generate qualitative collection in economical ways.
- Training in Open source software's like GSDL, KOHA, DSpace, E-Print etc.
- Advanced information searching techniques for data bases.
- Skill set development for the sustainability in profession.
- Programming and scripting languages, XML standards and technologies etc.

6. Need of Training in Academic Libraries:

Academic especially university libraries serve users from

all fields of studies and research and provide information / research support services to all information users i.e. students, teachers, researchers, scholars, outsiders etc. In the digital and technological age, only having efficient staff is not enough to meet ever increasing demands of the user community, but they have to be trained from time to time with the latest tools and techniques of information processing and its dissemination using ICT and softwares. Academic library professionals need competencies to manage professionals as well as personals. Professional competencies relate to knowledge on information resources, its access and utilization in providing better services to the user community. Personal competencies are the abilities, attitudes, skills and beliefs that enable individuals to perform effectively as a competent communicator, with an emphasis on lifelong learning to give value added services to the user community (Duarah, 2016).

Duarah (2016) pointed out some skills required by LIS professionals to be acquainted in the digital age are:

? Computer programming skills, web development skills, use of open / free software, institutional repositories programs, digital library and integrated library development

?Collection Development skills resource sharing skills
?ability to quickly adjust and adapting to new technology and incorporating them into the information services delivery

For continuous learning / training different programs are organizer by library associations, library alumina, special libraries, university libraries and these are also sponsored by organisations like UGC, AICTE, ICSSR etc. The programs are: Refresher/ Orientation courses, Workshops/Conferences/ Seminars, distance learning programs /online learning / e-learning courses or programs organized by SWAYAM, NPTEL etc.

7. How to Conduct Professional Training:

Before conducting training program there is a need to plan systematically for its organisation, viz. finding the area for conducting training, training needs, training schedule, training venue, trainer expertise, training information material, infrastructure related to technologies etc. Inform the trainers and trainees in advance about the content and coverage of the training area, modules covered etc. Trainer use multimedia power point presentations with hands on sessions are more effective in training for software, hardware, and practical subject area etc. Discussions among the trainees is essential, brain storming sessions will increase the value of training. Analyse the digestion of topics by trainees or participants from their feedback. Trainer must be from the same filed or related field but knowledgeable, good communicator, experienced, creative and demonstrating concept in ease

etc. Training will be fruitful only when set training goals are satisfied. "Train the trainer" is a model used to describe the practice of training faculty. Train the Trainer focuses on educating faculty about the challenges and barriers in a particular area or topic when users in libraries encounter problems. Faculty is first educated about the best practices and strategies for teaching and then they conduct programs and train others. The Training can be organized by conducting seminars, workshops, online training, librarian's discussion forums, etc.

8. Conclusion:

The Library and Information Science schools have to revamp syllabus of PG and UG courses based on the advancements. Main focus of education must bridge traditional areas with latest / current trends in the profession. Integrating technologies into their core curriculum and enhance the capabilities of professional students to sustain in the information society. Focus more on practical orientation. The education system in the LIS has to support Sustainable Development Goals of United Nations and National Education Policy 2020 wherein importance is given to higher education and information support by libraries. NEP 2020 has given prominence to primary and secondary school education and libraries have to support them in organizing information sources and building digital collection and digital libraries. These need the professionals to be trained to manage the change in information and education environment and also train the users in information and digital literacy. The curriculum of library schools should be reviewed taking into consideration the current job requirements of librarians as a sort of pre-service training efforts. Librarians should not move away from learning new concepts which would enable them to deal with the multi-disciplinary nature of library work in the technological era.

Introduction to Scheme of Financial Assistance

Scheme of Financial Assistance for Preservation and Conservation of Manuscripts, Rare Books, Old and Rare Documents, Record of History

The National Archives of India is established on 11th March, 1891 at Calcutta (Kolkata) as the Imperial Record Department. It is the biggest archival repository in South Asia. It has a vast corpus of records viz., public records,

private papers, oriental records, cartographic records and microfilms, which constitute an invaluable source of information for scholars-administrators and users of archives. It provides the financial assistance for scientific preservation/ conservation/ repair/ restoration of manuscripts, rare books, old and rare documents, record of history, and also for microfilming, listing, cataloguing, evaluation, translation, publication/ reprint of historical documents, charts, maps in their custody as also for purchase of manuscripts, rare books, old and rare documents, record of history.

In addition to this, financial assistance would be extended for preservation and conservation of archival photographs and prints (including oleographs & lithographs).

The assistance would also be provided for purchase of items required for Preservation and Conservation of Manuscripts, Rare Books, Old and Rare Documents, Record of History i.e. Air conditioners, vacuum cleaners, fumigation chambers and chemicals for treatment.

The Scheme would also provide financial assistance for Digitization of Manuscripts, Rare Books, Old & Rare Documents, Record of History, Archival Photographs & Prints (including support for digitization job work as well as purchase of equipments viz. camera, scanner, computer, printer, copier).

1. Eligibility

- National/State level voluntary organization, educational institutions, including private colleges, libraries and museums, universities, deemed universities, autonomous bodies of the Government (Central as well as States/Union Territories) archives & museums in various regimental centres, memorials of national leaders etc..
- Freedom fighters, families of erstwhile princely houses, old aristocratic families, individuals, temples, churches, khankas, mutts, having hereditary collections of manuscripts, records of historical importance, old & rare documents.
- Even in the absence of an application for financial assistance, if the Grants Committee has reasons to believe that particular archival materials, record of history lying in the custody of an organizations/ individual mentioned herein above are of national/unique in character, on the recommendation of the Expert Committee, may recommend *suo moto*, or member(s) of the Grants Committee direct to place the matter before the Grants Committee, for consideration of financial assistance under the scheme.

2. Extent of Financial Assistance

- The Financial Assistance will be of a non-recurring nature:-
- a. It will be in the ratio of 75:25 i.e. 75% central grant share and 25% institution's/individual's matching share for each project/proposal in a given financial year.
 - b. In case of important archival collections, the financial assistance will be in the ratio of 90:10 i.e. 90% central grant share and 10% institution's matching share.

c. In the case of central universities, the Government will bear 100% expenditure of a project covered under the scheme.

d. In special cases also the Government will bear 100% expenditure.

- The maximum limit of financial assistance under the scheme would be Rs.10.00 lakhs (Rupees ten lakhs only) per project/per financial year. A voluntary organisation/individual can submit only one project in financial year.

- The grant under the scheme will be considered after taking into the consideration of the grant received or likely to be received from other sources for the same project.

3. Procedure for Submission of Application

The organisation/individual should submit their application for financial assistance through the State Level Screening Committee (SLSC)/Archives in response to advertisement published in newspapers and in the website of NAI. In States/ Union Territory (UTs) where SLSC has been constituted, the applications should be submitted through SLSC only constituted for the purpose and in States/UTs where SLSC has not been constituted, the applications should be routed and recommended through concerned State/UT Archives. The SLSC/UT Administrations / Archives will forward the applications to the Director General of Archives and Chairperson, Grants Committee, National Archives of India, Janpath, New Delhi-110001, with their specific recommendations indicating the amount of grant and purpose for which grant is sought for. Universities (including deemed universities) may send their applications directly through the Registrar. In case of private colleges affiliated to the universities, the applications should be forwarded through the Registrar of the respective university. Incomplete or applications received after the prescribed date will not be considered.

Documents required to be submitted, alongwith the application:-

- A project report indicating the proposal for which the financial assistance is sought, alongwith the qualifications and experience of the experts engaged or proposed to be engaged on contract basis.
- Financial statement of the project giving item-wise details of non-recurring expenditure and source from which grantee will meet the matching share.
- Information relating to the grant received, promised or the requests thereof made, if any, to other bodies, e.g. universities, central/state governments, central social welfare board or local bodies/quasi-government institutions for the project under the consideration. The decision of these bodies on such request should be communicated to the Director General of Archives, National Archives of India, (Ministry of Culture, Government of India), New Delhi.
- List of manuscripts, rare books, old and rare documents, record of history in the custody of the voluntary organisation/individual and universities, stating the titles, authors, inclusive years, subject and language.
- Valid and legible registration certificate of the organisation (wherever applicable) or other proof of its origin.

- Constitution of the board of management of the organisation and the particulars of each member.
- Copy of the latest audit and annual report.
- A statement of full receipts and expenditure of the institution/organisation for the previous three years and a copy of the balance sheet for the previous year certified by a Chartered Accountant or Government Auditor.

Statistical method is an essential and vital tool for conducting and completing research. It helps in designing the research, analyzing and interpreting data. This requires a proper design of the study, an appropriate selection of the study sample and choice of a suitable statistical test. An adequate knowledge of statistics is necessary for proper designing of study.

The Book "Statistical Techniques in Research" is a piece of wonderful work where techniques of statistics are explained aptly keeping the practical approach in mind. The researchers who aspire to complete the research on right time will find this book helpful as it explains clearly all the statistical techniques in very simple and understandable language. It starts with explaining basic concepts of research and gradually focuses on statistical techniques as the title of the book mentioned.

It is well organized and divided into 10 chapters. Chapter 1 sets the background of the book with brief discussion on concept and types of research. In Chapter 2- 4, discusses sample selection, Hypothesis, Statistics and Data presentation is with practical examples. Further in Chapter 5-10 Statistical measures and Testing Hypothesis is discussed with illustrative examples.

In each area of the book the authors recommend the examples related to library science field which is very important for practical understanding of the concept. Finally, any budding researcher who is on verge to start the research will find all answers related to statistical approaches of research and will be able to successfully apply them in ongoing research. For experienced researchers this book forms the perfect blend of statistical techniques and real examples faced during research to set the broad conceptual foundation.

International E-Seminar on Changing Scenario of Academic Libraries and National Policy of India 2020 (CSALNEPI-2021)

Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori Dist. Gadchiroli organized an International E-Seminar on 'Changing Scenario of Academic Libraries and National Education Policy of India 2020' in collaboration with Kavikulaguru Kalidas Sanskrit University, Ramtek; Renuka College, Besa, Nagpur; Government First Grade College, Saligrama, Mysore, and Goa Multi-Faculty College, Dharbandora, Goa. Inaugural Session:


